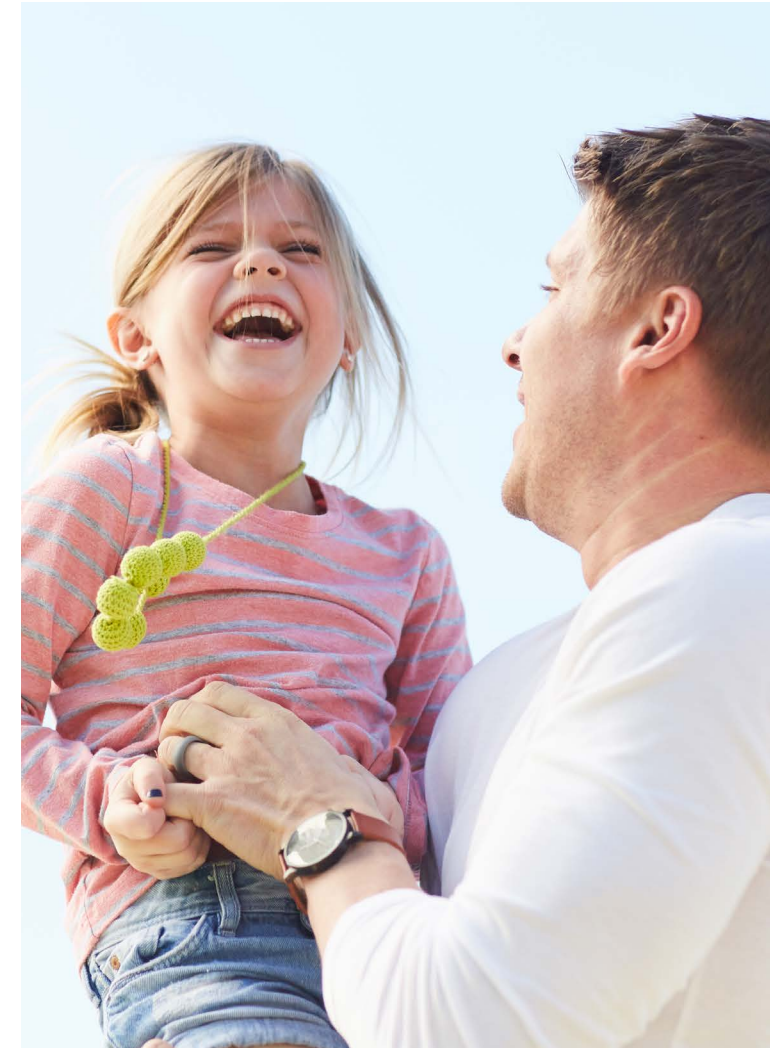

## Who are we?

Horizons Family Law Centre (Horizons FLC) is a not for profit legal service and charity that has been operating since 2005.

## What do we do?

Horizons FLC provides a mix of free and low cost legal help to people dealing with parenting disputes, domestic violence and other safety concerns.

Entry to our service is generally through our telephone advice line, which operates on Tuesdays and Thursdays.

We can provide ongoing advice and help with tasks like preparing court documents and, for families in the most extreme need, full representation in court.

## Who can we help?

Our telephone advice line is a first port of call for anyone in the community dealing with parenting disputes or domestic violence.

Our higher levels of help are targeted towards people who don't qualify for legal aid and can't afford a private lawyer.
